## BURSARY APPLICATION FORM INSTRUCTIONS

Please review the instructions carefully before completing your application. All applicants are encouraged to contact their local Legion branch if you have any questions about the process.

### Section I – Student Information

- Provide your full legal name as it appears on government issued identification.
- Enter your current home address at the time of application.
- If your mailing address is different from your home address, complete both fields.
- Applicants must reside in British Columbia or the Yukon and be Canadian Citizens.
- Provide a valid email address and phone number where you can be reached.

### Section II – Post Secondary Institution Information

- Provide the full name, address, and phone number of the post secondary institution you will be attending. If the post secondary institution has multiple campuses, identify the specific campus location.
- The post secondary institution must be in British Columbia, Alberta, or Yukon.
- Bursaries are awarded to students attending an accredited institution full-time or two consecutive semesters. Post-graduate studies are not eligible.
- Up to \$2500.00 per student may be awarded to successful applicants attending an accredited post secondary institution, including vocational and trade schools.
  - This amount is a guideline only. Individual Legion branches may adjust the award based on available funds and the number of applicants.

### Section III – Financial Information

- This section helps determine financial need. Complete category A or B, depending on your situation.
- A – Dependant Students
  - Complete this section if you live with your parent(s)/guardian(s) or are considered a dependant for tax purposes.
  - Indicate your family's taxable income from the previous tax year.
  - Indicate the number of people living in the household.
  - Bring a copy of the most recent Canada Revenue Agency Notice of Assessment for verification for your household to a follow up Legion branch interview.
- B – Independent Students or Those with Dependents
  - Complete this section if you live independently, are financial independent, or have dependants of your own.
  - Indicate your family's taxable income from the previous tax year.
  - Indicate the number of people living in the household.
  - Bring a copy of the most recent Canada Revenue Agency Notice of Assessment for verification for your household to a follow up Legion branch interview.

- C – Income & Resources (to be completed by all applicants)
  - Provide the amounts you expect to receive for the upcoming academic year, including: employment income, Registered Education Savings Plan (RESP) withdrawals, parental or guardian contributions, any taxable government grants.
- Financial need is evaluated in part using the gross household income thresholds established by the Canada Student Grant for low and middle income families. Special exceptions may apply.

#### Section IV – Military Service Information

- Bursaries are available to students who are veterans, or who are the child, grandchild, great-grandchild, parents of a veteran, or spouse of an eligible person, and who demonstrate financial need.
- An eligible person is defined under The Royal Canadian Legion's General By-Laws subsection 101.d.:

*A Veteran is any person who is serving or who has honourably served in the Canadian Armed Forces, the Commonwealth or its wartime allies, or as a regular member of the Royal Canadian Mounted Police, or as a Peace Officer in a special duty area or on a special duty operation, or who has served in the Merchant Navy or Ferry Command during wartime.*

- If you are applying based on a connection to veteran or serving member of the Canadian Armed Forces or RCMP:
  - Provide the name of the individual whose service you are using to establish eligibility.
  - Identify your relationship to that individual and provide their Service Number (Canadian Armed Forces (CAF) or Royal Canadian Mounted Police (RCMP)).
  - Indicate whether you have included the required supporting documentation (eg. service record, discharge paperwork).
